## STALLION SERVICE AGREEMENT 20\_\_\_\_\_

This certifies that \_\_\_\_\_, herein referred to as Mare Owner, has engaged one breeding to **My Significant Other**, APHA registration number 430,187, for the 20\_\_\_\_ Breeding season at \$400 for the mare \_\_\_\_\_, Registration number \_\_\_\_\_, for a live foal.

1. Booking fee of \$200 to be paid upon execution of this agreement. This booking fee is not refundable.
2. The remaining balance of \$200 for the breeding shall be paid when the mare arrives at the Breeder's farm or Vet Clinic, payable to Sunburst Paint Horses. All board, farrier, veterinarian and breeding fees are payable by the Mare Owner monthly as and when billed by the Breeder or Veterinarian, and all such charges are in addition to the Stallion Service fee. All fees and charges must be paid to Breeder monthly and, in any event, before the mare is released to the Mare Owner. Mare care will be charged and is payable whether the mare is settled or not.
1. The mare and foal must be delivered halter broke and in a healthy, breed able condition, free from any known sickness, disease or infection and accompanied with the following: (a) photocopy of mare's registration papers, (b) current negative coggins report, (c) documentation of immunizations and worming including equine influenza, rhinopneumonitis, Eastern and Western encephalitis, West Nile and Tetanus (d)current negative uterine culture. If these documents are not presented upon arrival of the mare, the Breeder may have the attending veterinarian make the proper tests and evaluations at the Mare Owner's expense.
  2. Should the mare, after being checked in foal, abort, or not have a live foal, the Mare Owner will be entitled to (a) a return privilege for the remainder of the breeding season or (b) a return privilege to the stallion the following year only. Live foal means the foal shall stand and nurse. A booking fee of \$200 must be paid for mares returning for rebreed the following year.
  3. Should the stallion die or become unfit to breed, before said mare is pronounced in foal, this contract shall become null and void and any stallion service fee paid, less booking fee, shall be returned.
  4. It is agreed that the attending veterinarian for and/or the Breeder shall check the mare for normal breeding conditions and perform such other veterinary services for the mare (and foal) as is deemed necessary at the expense of the Mare Owner. This includes such reasonable services as worming, treating for disease and infection, preventative measures, original examination, ultrasound, collection and insemination. Any emergency veterinarian care necessary will be performed without prior notification and at the expense of the Mare Owner.
  5. A Breeder's Certificate will be furnished by the Stallion Owner to the Mare Owner upon notification of the birth of a foal.
  6. When Mare Owner signs and returns one copy of this contract to the Breeder, it shall bind and benefit both parties and their respective heirs, legal representatives, successors and assigns. This contract shall not be assigned. This contract shall be construed and enforced in accordance with the laws of Minnesota and the parties agree that any action regarding the unenforceability of any provision of the contract shall not affect the validity or enforceability of any other provision of this contract.
